BY WORKING WITH A NETWORK OF PROGRAMS, WE LEVERAGE RESOURCES AND PROVIDE THE SUPPORT AND TOOLS NEEDED TO REACH YOUNG PEOPLE. IN 2019, WE WORKED WITH HUNDREDS OF LOCAL PROGRAMS TO SERVE 20,000+ YOUNG PEOPLE THROUGH MENTORING.
