IN 2021, WE PROVIDED TECHNICAL ASSISTANCE, TRAINING AND SUPPORT TO A NETWORK OF 150+ MENTORING PROGRAMS SERVING 20,000+ YOUNG PEOPLE IN MORE THAN 13 WESTERN PA COUNTIES. WE DELIVERED PRE-MATCH AND CONTINUED EDUCATION TRAININGS TO 1078 ADULT VOLUNTEER MENTORS AND 242 YOUTH (MENTEES).
