This November, The Mentoring Partnership of Southwestern PA will be holding a #ThankYourMentor sweepstakes to encourage people to share their mentoring stories on social media. To encourage participation, all entries submitted between Nov. 9 - Nov. 27 will be entered into a sweepstakes. At the end of November, one lucky person will be randomly selected as the prize winner. In order to be considered, your post must use the hashtag #ThankYourMentor, tag The Mentoring Partnership of Southwestern PA, and tag two friends, challenging them to participate.

Prize

The winner will receive one \$50 Visa e-gift card.

How To Enter

Rules:

1. Publish a post thanking a mentor outside your family and make sure to include a photo or video
2. Use hashtag #ThankYourMentor in your caption
3. Tag The Mentoring Partnership of Southwestern PA on the respective social media platforms ([Facebook](#): @MentoringPGH [Twitter](#): @MPSWPA [Instagram](#): @mentoringpgh)
4. Tag 2 friends in your caption encouraging them to also post
5. Make sure your account / post is public



The sweepstakes period runs from November 9, 2020 (12 PM EST) - November 30, 2020 (12 PM EST). This sweepstakes is open to legal residents of the United States who are 18 years of age or older. Winners will be randomly selected and then contacted via direct message on the platform where they entered (Facebook, Twitter, or Instagram). If the selected winner cannot be contacted, is ineligible, or fails to claim the prize within 48 hours from the time the award notification was sent, prize may be forfeited and an alternate winner selected. Winners must provide an address to process and deliver the prize, and may be asked for additional information. Employees of The Mentoring Partnership of Southwestern PA are not eligible to win. 1. PROMOTION DESCRIPTION: The Thank Your Mentor sweepstakes ("sweepstakes") begins on November 9, 2020 at 12:00 PM ET and ends on November 30, 2020 at 12:00 PM ET (the "Promotion Period").

The administrator of this sweepstakes is The Mentoring Partnership of Southwestern PA ("Administrator"). This campaign is not affiliated with Instagram, Facebook, Twitter or LinkedIn. By participating in the sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Administrator, which shall be final and binding in all respects. Administrator is responsible for the collection, submission or processing of Entries and the overall administration of the sweepstakes. Entrants should look solely to the Administrator with any questions, comments or problems related to the sweepstakes. Automated or robotic Entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant. Final eligibility for the award of any prize is subject to eligibility verification as set forth below. All Entries must be posted by the end of the Campaign Period in order to participate. Administrator's database clock will be the official timekeeper for this sweepstakes.

5. WINNER SELECTION: The winners of the sweepstakes will be selected in a random drawing from among all eligible Entries received throughout the Campaign Period. The random drawing will be conducted by the Administrator or its designated representatives, whose decisions are final. Odds of winning will vary depending on the number of eligible Entries received.

The Mentoring Partnership of Southwestern PA has the right, at its sole discretion, to maintain the integrity of the sweepstakes, to void entries for any reason, including, but not limited to; the use of bots, macros or scripts or other technical means for entering. The entry must come from a person's individual account and not be a meme, community, company, or product account. The organization reserves at its sole discretion the right to choose an alternative qualifier in the event that a qualifier has been disqualified or is deemed ineligible. The organization will not accept screenshots or other evidence of winning in lieu of its validation process.
